Dear President Ayers, Secretary-Treasurer McGarvey;

We need your help, and we need it now! And not only in St. around the nation.

I am referring to the continued, and expanding efforts by the Carpenters. Union to want to WRECK the AFL-CIO building trades here in St. Louis and, with only a few exceptions, around the nation based on conversations? I've had with my counterparts elsewhere.

But let me address the St. Louis situation, which is getting more serious, literally by the day, Here, the St. Louis Carpenters' District Council, which after their merger with Southern Illinois locals, has over 20,000 members and a large treasury, has:

- Unilaterally abrogated agreements with our various trades, agreements that have been in effect for decades and provided a working, haimonious relationship on jobsites;
 - · Created a electricians local with non-union contractors and has undercut the wages and conditions of our affiliate, IBEW Local 1. To date, they have eight non-union electrical firms signed up, offering thein special conditions so that they can undercut costs and steal work: from our IEEW affiliate

 And owners, who are faced with difficult economic conditions today, are growing frustrated. They could well begin demanding that the contractors start using non-union firms, and then all hell will break loose!

St. Louis is a great union town. AFL-CIO unions do 85 percent of all commercial construction and 75 to 80 percent of homebuilding. It has been that way for decades; that is now all threatened because of the willingness of the carpenter to say "To hell with everyone I want all the work, regardless." Traditional and negotiated jurisdictions mean nothing to them anymore.

Unless the Building Trades Department and affiliated International Unions (and their local union affiliates) take a united, decisive and immediate stand against this effort by the carpenter, we are going to see the complete destruction of the AFL-CIO building trades in our country. It's no secret that union construction is now overshadowed by non-union across that union construction is now overshadowed by non-union across that union construction is now overshadowed by non-union across that union construction is now overshadowed by non-union across that union strongholds like St. Louis left. Unless there is America. We have few union strongholds like St. Louis left. Unless there is unified action by the building trades unions across America, the carpenter will be successful—and ultimately will be the ONLY building trades union left.

There has been talk of starting a competing carpenters union under the AFL-CIO banner. We have heard from many local rank-and-file carpenters that they don't like what is happening but they have no way to fight it; the carpenter's organizational structure prohibits rank-and-filers from protesting. The head of the local district council, and others across the nation, are shielded from democratic elections where members could protest by challenging existing leadership as a protest. We have union carpenters who have relatives in the other trades and it hurts them to be stealing a brother, brother-in-law or uncle's work. But they have no choice at the moment.

We believe that strong action is needed, NOW:

- 1. A new Carpenters Division or Union within the AFL-CIO Building Trades Department needs to be created quickly, initially funded by the other International Unions.
- 2. This new division needs substantial advertising and marketing funds to take the issue directly to the local union members in our major cities to let them know there is an alternative available to them. An adequate marketing budget should be included in any funding effort.
- 3. A health and welfare plan needs to be negotiated by the BCTD with a national provider like Blue Cross/Blue Shield so that carpenters unhappy with the current situation can change and know this critical service will be available to them.
- A. There needs to be a process established so that other benefits like a pension plan can also be available to the newcomers, especially the younger carpenters who are not yet vested. Frankly, the vast majority of carpenters will undoubtedly be vested in their current plan but a new one needs to be available both for the younger members as well as the older ones who can see a second pension in their future.

Brother Ayers, Brother McGarvey, I know this is not an easy thing to launch. But unless something is done quickly, union towns like St. Louis will continue to lose work and market share to the point we become irrelevant and ineffective.

Even AFL-CIO President Richard Trumka recognized the need at the most recent AFL-CIO Convention, where he said," That to truly succeed we need an AFL-CIO that speaks for all union members – a movement that's both united in name – and united in purpose."

I can appreciate that the Change To Win split within the AFL-CIO was his main focus. He is trying to unite all of Labor for our common good. Certainly, the Building Trades would be better off if the United Brotherhood of Carpenters decided to re-affiliate and act like the true trade union it used to be. But I believe the BCTD already tried that and was cold-shoulder by the UBC. If that's the case, then enough is enough! We need action to counter their efforts to destroy ALL OF US, and we need it NOW.

On behalf of the 25,000 members we represent, we are calling on the Department and all BCTD affiliated International Unions to step up and take unified action; make a final effort to get the UBC back into the House of Labor and if they refuse, have a plan in hand to immediately launch an AFL-CIO Carpenters Union. We will support that effort in the field, not only in St. Louis, but around the nation! We cannot afford to wait any longer.
