

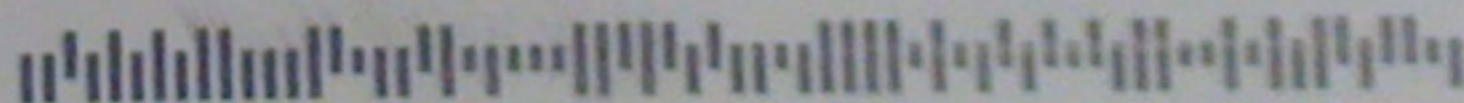

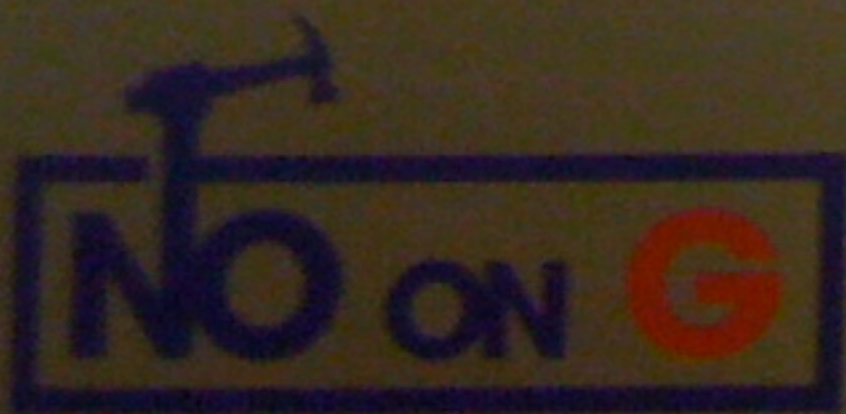
Proposition G will Ban me from working on the Bayfront.

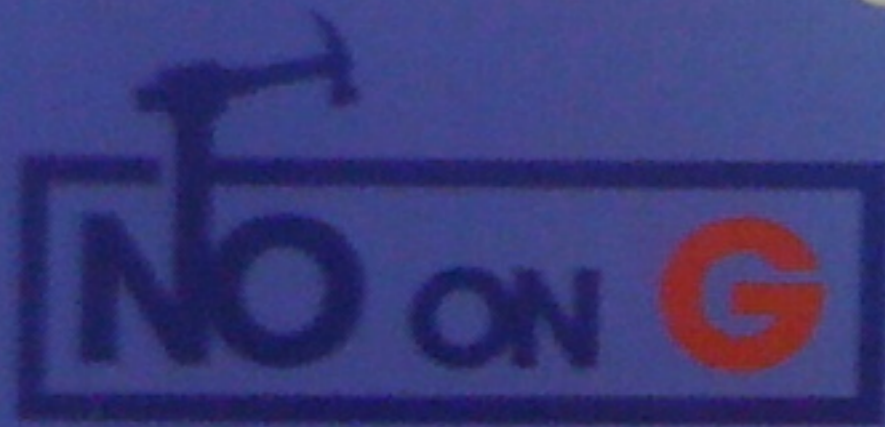
Proposition G will Ban me from working on the Bayfront.

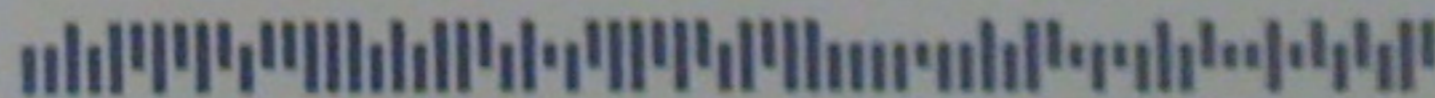

Proposition G will Ban me from working on the Bayfront.

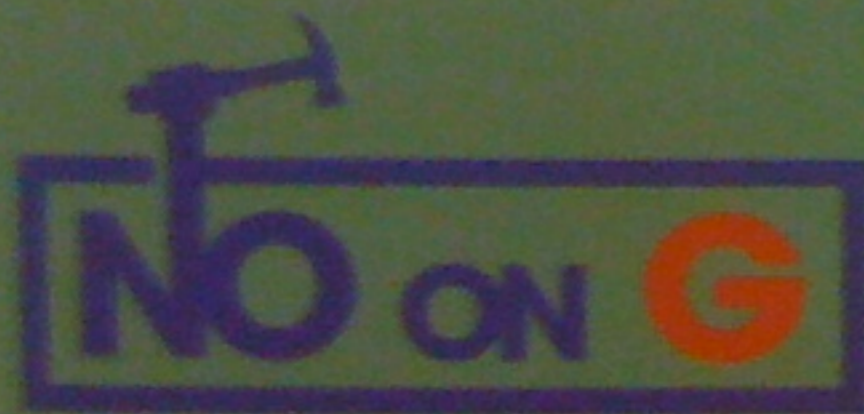
I've lived in Chula Vista for 20 years. I pay taxes. I coach soccer and baseball.

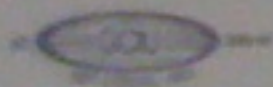
